### 1 / What is the purpose of this update?

This document tells you how the Aspiring Fund has performed and what fees were charged. The document will help you to compare the Fund with other Funds. Aspiring Asset Management Limited ("Manager") prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### 2 / Description of this Fund

The Aspiring Fund principally invests in listed Australasian equities, although it may invest in any asset class (including foreign shares, investments in unlisted entities, underwriting arrangements, debt securities, and property). The principal objective of the Fund is to achieve positive absolute returns averaging at least 4% over inflation (after fees and expenses but before tax) over the long term.

## 3 / What are the risks of investing?



Investors in the Aspiring Fund are charged Fund charges. In the year to 31 March 2020 these were:

### 6 / Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after Fund charges were deducted of \$592 (that is 5.92% of his initial \$10,000). Sam paid no other charges. This gives Sam a total return after tax of \$592 for the year.
