

Details of the Scheme

The Scheme is the Aspiring Fund, which is a Managed Investment Scheme. The Manager of the Scheme is Aspiring Asset Management Limited. The supervisor of the Scheme is New Zealand Guardian Trust Limited.

The Product Disclosure Statement, dated the 23rd day of September 2022, is open for applications.

The latest fund update, dated 30th day of June 2023, was lodged with the Registrar on the 11th day of July 2023.

The Scheme's latest financial statements dated the 31st March 2023, and the auditor's report, dated the 11th July 2023, were lodged with the Registrar on the 18th day of July 2023.

Description of the Scheme

The Fund principally invests in listed equities, although it may invest in any asset class (including investments in unlisted entities, underwriting arrangements, debt securities, and property).

The Scheme was established by a master trust deed and an establishment deed, both dated the 17th of September 2015.

Information on the Composition of the Scheme

This Annual Report covers the accounting period from the 1st of April 2022 to the 31st of March 2023.

The number of managed investment products on issue at the start, and end of the accounting period was 1.

Changes relating to the Scheme

The Scheme transitioned to the Financial Markets Conduct Act 2013 (FMCA) on the 17th of September 2015.

There have been no material changes to the nature of the Scheme, the investment objectives and strategy, or the management of the Scheme over the accounting period.

There have been no related party transactions (as defined in section 173 of the FMCA) entered into during the accounting period.

The unit price for the fund at the start of the accounting period was \$5.1026. (1st April 2022)

The unit price for the fund at the end of the accounting period was \$5.1499 (31st March 2023)
